THIS REVIEW IS MANDATORY AND LEGALLY BINDING

The Forest at Panther Ridge Homeowners' Association, Inc. (Association), through the Building Review Board (BRB), requires the review of all proposed improvements to any tracts. This process helps fulfill the requirement that the Association ensures compliance with the Protective Covenants and Bylaws, as well as maintaining the value and beauty of all homes and properties within The Forest. When a tract is purchased in The Forest, the purchaser signs a legal agreement to follow certain binding provisions, including the requirement to submit plans and specifications of all proposed improvements for review by the Association and to be bound by the Association's decision. It is mandatory that homeowners receive written approval of any planned improvements prior to any site preparation and/or construction, unless the construction is specifically **pre-approved** in the Land Planning Guidebook. If in doubt, please contact the BRB chairperson. The Association must take action against any Owner and/or Contractor who violates the Association's Protective Covenants and/or Bylaws.

As part of fulfilling required duties under the Protective Covenants and By-Laws, the Association:

- 1) may enter tracts in the Forest to review any improvements for compliance with the BRB's written approvals (Declaration of Protective Covenants 1996, Article 6, Section 6.01(c));
- will require the removal of all improvements wherein: (a) there is no BRB written approval of those improvements requiring approval; and/or (b) the approved improvements are not completed in compliance with the underlying plans and/or specifications of that approval.

APPLICATION FORM AND FEES

Declaration of Protective Covenants 1996, (Article 8 (Use and Building Restrictions) Section 8.13(g)), the Association acting as the Building Review Board may establish reasonable fees for review of applications. As of this revision (Version 22.1), there is no charge for a short form application for minor improvements.

APPROVALS AND OTHER PERMITS

Owners/Contractors are hereby informed that Building Permits issued by Manatee County without the written review and approval of the BRB <u>does not permit you to build in The Forest</u>. Likewise, a written approval by the BRB without a Building Permit issued by Manatee County <u>does not permit you to build in The Forest</u>. <u>BOTH</u> approvals are <u>REQUIRED</u> and are legally binding. The absence of one means <u>you cannot build</u> <u>until you have BOTH written approvals</u>. Immediate action will be taken against those who do not comply or who build and/or vary their construction from the approved plans and/or specifications.

INSTRUCTIONS

- 1. All owners wishing to build any type of structure or improvement in The Forest must receive written approval from the BRB <u>prior to any site preparation and/or commencement of any type of construction.</u>
- 2. Complete this application fully and accurately. The Forest at Panther Ridge Homeowners' Association, Inc. and the BRB will require the removal of all construction that has not been approved or construction that deviates in any way from prior written approvals of the BRB.
- 3. Your application is unique and cannot be compared to other applications either denied or approved.
- 4. Please answer all questions and provide all documents requested.
- 5. Please do not submit an application that is incomplete or has any blank spaces. It will be immediately rejected and sent back to you for completion. Submitting a <u>complete</u> package will greatly speed your approval process.
